THE MUSEUM STRIVES TO BE ONE OF THE NATION'S MOST EFFECTIVE CENTERS FOR LEARNING THROUGH ART AND HISTORY BY DEVELOPING THE BEST POSSIBLE EDUCATIONAL EXPERIENCES FOR SCHOOLCHILDREN, FAMILIES AND ADULTS THAT REFLECT AN UNDERSTANDING OF THE DIFFERENT LEARNING STYLES VISITORS BRING TO THE MUSEUM. THE MATTATUCK RECOGNIZES THAT FAR TOO MANY CHILDREN AND FAMILIES HAVE LITTLE TO NO ACCESS TO THE BENEFITS OF REGULAR EXPOSURE TO THE FINE ARTS.
