AS WELL, THE COVID PANDEMIC HAD A SEVERE IMPACT RESULTING IN A PERIOD OF CLOSURE FOLLOWED BY A CURRENT PERIOD OF REDUCED VISITATION AS WE FOLLOW STATE REGULATIONS.
